## WHAT IS A MARKET BUCK?

Market Bucks are Jockey Lot coupons valued at $\$ 10$. These coupons are handed out at gatherings attended by management as an advertising tool to promote individuals to come shop with our Vendors. Should a customer choose to spend their Market Buck(s) at your booth please accept it. They spend same as cash. Then simply come to the office with the Market Buck, and we will give you $\$ 10$ cash. EX: If a customer spends $\$ 7$ with you and they use the $\$ 10$ Market Buck you should not give change, this is a one and done. When you come to the office, you will however receive $\$ 10$ cash from us.

## BROKEN GLASS

Should accidentally break a glass item, mirror, etc. Please do not place the broken glass in the trash barrels. This causes a danger to our staff when collecting. Please notify the office for proper disposal.

## TRASH

Please remember that the trash barrels are for customer use. Vendor may NOT dispose of unwanted, broken merchandise or any other items in the trash barrels. What comes with you must leave with you.

## REMINDER

The Jockey Lot is OPEN until 5:00 PM Saturdays and Sundays. Vendors are required to follow shopping hours. We have recently received comments from customers questioning why so many of you are leaving at 2 and 3 pm . In early May we began noting those Vendors. Currently there is no penalty, but should this problem persist penalties may become necessary.

## 400 SECTION PARKING

Additional B400 covered booth spaces have been added to the front of the 400 Section.
Parking directly adjacent to a rental space is not guaranteed and is based on the location of the space. With the addition of these new B400 Rental Spaces, parking adjacent to your 400 Section space is not available. It is your responsibility to park in the General Parking area.

## 700 RESERVABLE SPACES

Parking at a booth in the $\mathbf{7 0 0}$ Reservable area is prohibited. These Vendors are currently using what would be a designated parking space as a vending area. Regarding Loading/Unloading: Please load/unload within 15 minutes and park in the grassy area behind the outdoor cement tables.

## RENT PAYMENT

Please be reminded that in order to retain your Booth Space, rent must be received in the office by 3:00 PM Sunday. Those Vendors not paying rent risk losing their booth space. Vendors are always welcome to call with a credit card to secure their booth space for the following week.
