### **FAMILY FUN DAY RAFFLE**

### **WHAT IS A MARKET BUCK?**

Market Bucks are Jockey Lot coupons valued at \$10. These coupons are handed out at gatherings attended by management as an advertising tool to promote individuals to come shop with our Vendors. Should a customer choose to spend their Market Buck(s) at your booth please accept it. They spend same as cash. Then simply come to the office with the Market Buck, and we will give you \$10 cash. EX: If a customer spends \$7 with you and they use the \$10

Market Buck you should not give change, this is a one and done. When you come to the office, you will however receive \$10 cash from us.

### **PAYMENT OF BOOTH RENT- 3:00 PM SUNDAY**

Reminder: Absenteeism does not excuse a vendor from rent payment for the upcoming week. Please make appropriate measures to pay your rent by 3:00PM Sunday. By not paying your rent timely, you risk losing your booth space.

### **CLOSING EARLY NOTICE**

We understand extreme heat causes business to slow this time of year. However, you as well as your neighbor may be losing out on potential sales by closing early. Vendor Rules and Regulations state shopping hours are: **SATURDAY 9:00 AM - 5:00 PM and SUNDAY 10:00 AM – 5:00 PM. Beginning Saturday, September 16th Vendors closing prior to 4:00 PM will be charged a “Closing Early” fee of \$7.00. Closing Early = Loss of Revenue for all**

### **FIRE EXTINGUISHERS**

Please be aware that should a fire extinguisher be stationed in your booth space it is mandatory that it remain exposed and available in an emergency. **You may NOT cover this area with decorative items or drapes.**

### **ELECTRICITY**

Just a reminder – each booth allows for two plug -ins. When you use your outlets for multi-strip extensions, it places a tremendous strain on the electrical system (especially in the hot weather). Please do not plug multiple items into your outlets as it causes the system to fail and inconvenience you and all those vendors around you. This is especially true for food vendors. **FOOD VENDORS:** Please remember you should be using propane warming plates only. Using multiple refrigerators and appliances in one space is not allowed. If you use appliances, there is a \$25 electrical charge weekly. Appliance use is one (1) appliance per booth. Use of additional appliance will result in additional charges per appliance. Additional booths with appliances will also incur charges. (I.E., 2 booths with appliances used by one vendor will be an additional \$10 electrical charge for the second booth or \$35 total).

### **SMOKING**

Please be Reminded: Smoking is prohibited in the Lafayette Jockey Lot. This law pertains to vendors as well as customers. Anyone wishing to smoke must be 15’ from the buildings – Vendors and Customers.

### **NOISE**

Management understands that many vendors wish to play music in their booth space. Please note, this music should be for the enjoyment in your booth only. **Noise levels are required to remain at a level enjoyable to your booth/customers only.**
