Just a reminder: Vendors of the 700 Lockable Booths will receive mandatory Pest Control at the cost of \$2.00 per booth per week. Due to the nature of the product sold in this aisle, it is necessary to be proactive and prevent the problem of pest issues. We would also ask that all Vendors throughout the Market keep their booth clean, removing food at the end of each day, etc. as a preventative measure in pest control.

THIS N' THAT AT THE JOCKEY LOT – THINGS VENDORS SHOULD KNOW:

WHAT IS A MARKET BUCK

A MARKET BUCK is a coupon valued at \$10. They are accepted same as cash. When presented, Customers may spend same as cash. However, DO NOT give change-it is spend all or lose balance. Vendors should turn any Market Bucks received in At the office for \$10 CASH reimbursement.

ANNOUNCEMENTS

Vendors may pick up a blank vendor announcement form at the office and we will make your announcement for you. One announcement form per booth. Should you rent 2 booths = 2 Announcements, etc...

ELECTRICITY

Reservable and Lockable spaces allow for 2 plug-ins. Please **DO NOT** plug multiple items into your outlets. No multi-use power strips please! This causes issues for your fellow Vendors.

FOOD VENDORS

If you use an appliance (limit 2) there is a \$25 per week electrical charge. Using more than 2 appliances will result in additional charges. Please use propane warming plates when possible.

FREE MONTHLY BISCUIT

On the last Sunday of each month, Vendors receive a **FREE BISCUIT**. Simply come to the kitchen window, let them know your booth number and receive your free biscuit.

CLOSING EARLY

By closing early you as well as fellow Vendors may be missing out on sales. The Jockey lot is open until 5:00 PM on both Saturday and Sunday.

Vendors are required to remain open until 4:00 PM or face a \$7 closing early charge.

OPENING LATE

Shoppers arrive early for bargains. Shopping hours are Sat. 9 AM – 5 PM and Sun. 10 AM- 5 PM. Opening Late = \$7 charge

SMOKING

Smoking is prohibited in the Jockey Lot. This law pertains to Customers, Vendors and Employees. Smoking must occur 15' from the building.
