MAINTENANCE REPAIRS:

General Maintenance: Should you experience a maintenance issue please report it to the office as soon as possible.

Booth Space: Please be reminded that the yellow floor markings outline the perimeters of your rented booth space. Fire Dept. regulations require you not exceed these dimensions as appropriate aisle space is required for safety purposes.

Vendors renting a Reservable Space should be reminded that per your Terms & Conditions:

All merchandise needs to be picked up by the end of day Sunday. Leaving Saturday shopping and Saturday overnight into Sunday shopping is allowed. However, leaving merchandise in your booth over the week puts you at risk for theft or disposal.

PLEASE BE SURE THAT YOU ARE IN YOUR ASSIGNED SPACES

All spaces have been rented so when you set up in spaces that you didn't rent it causes problems for everyone. And isn't fair to the person who paid for the spot to have to wait for you to move your things. Please be considerate of your fellow vendors. This includes pulling tables from another booth space. We are extremely limited on tables. We appreciate your cooperation!

GENERAL REMINDERS

- To secure your booth for the following week your rent is due in the office by 3:00 PM Sunday. If not received, your booth becomes available to online renters at midnight Sunday. Should you call the office to pay your rent, please do so early. Our staff is busy collecting rent at the window and often is unable to answer your call after 1:00 PM.
- We understand the holidays were busy and we were all looking forward to getting home to our families but the policy of not leaving merchandise still applies. Be reminded that we will start strictly enforcing the \$25.00 trash fine at the first of the year. Please take a few minutes at the end of each day to make sure you have picked up any trash and all merchandise is taken with you or stored in your lockable. Failure to comply could resort in merchandise being disposed of per your terms and conditions.
