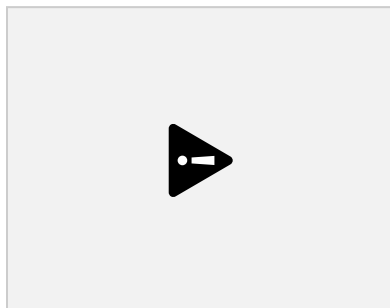
COMING EVENTS

ACCEPTING MARKET BUCKS:

A **MARKET BUCK** is a coupon valued at \$10 given as a promotion. This is done to help you succeed by attracting SHOPPERS to the JOCKEY LOT. **Vendors – YOU MUST accept MARKET BUCKS same as cash.** When presented, accept them (same as a cash purchase), but **DO NOT give the buyer change!** Market Bucks are a spend it all or lose the balance. Vendors should turn any Market Buck received in at the office for a \$10 CASH reimbursement.

PLEASE- DO NOT TELL A CUSTOMER YOU ACCEPT CASH ONLY.

A Market Buck spends same as cash - you may be CASH ahead in the end.

EXAMPLE: Should a Customer purchase an Item for \$5.00, you are **REQUIRED TO ACCEPT THE MARKET BUCK** and turn it in at the office. When you present the Market Buck to our Office Staff, they will give you \$10 CASH! You would be ahead \$5.00!!!

RENT REMINDER:

To secure your booth for the following week your rent is due in the office by 3:00 PM Sunday. If not received, your booth becomes available to online renters at midnight Sunday. Should you call the office to pay your rent, please do so early. Our staff is busy collecting rent at the window and often is unable to answer you call after 1:00 PM.

MAINTENANCE REPAIRS:

General Maintenance: Should you experience a maintenance issue please report it to the office as soon as possible.

Booth Space: Please be reminded that the yellow floor markings outline the perimeters of your rented booth space. Fire Dept. regulations require you not exceed these dimensions as appropriate aisle space is required for safety purposes.

If anyone is looking to rent a container, we have 2 available so stop in with the office if you're interested!
